I hereby state that I am experienced in and familiar with the operation of motorcycles and fully understand the risks and dangers inherent in motorcycling. I am voluntarily participating in the charity ride, and I expressly agree to assume the entire risk of any accident or personal injury, including death that I or my passenger might suffer as a result of my participation in the charity ride. I participate in the ride knowing the existing weather conditions, road conditions and other similar conditions and factors associated with this ride could be hazardous.

For and in consideration for the opportunity to engage in the ride for charity. I (on my own behalf and on behalf of my heirs, personal representatives, successors and assigns) do hereby release and forever discharge the released parties (including their officers, directors, employees, agents and insurers) from any and all claims, demands, rights and causes of actions of any kind whatsoever which I or my passenger now have, or later may have, known or unknown, in any way resulting from or arising out of my participation in this ride.

This release extends to any and all claims that I or my passenger have or may have against the released parties whether such claims result from strict liability or negligence on the part of any of all of the released parties with respect to the design, manufacture, report or maintenance of the motorcycles(s) which I will be riding during the charity ride, or with respect to the conditions, qualifications, instructions, rules or procedures under which the ride is conducted or from any other cause. However, I do not release any released party from any intentional misconduct on their part.

I will conform to all rules and regulations of the Canadian Oilfield Riders Charity Run. I will obey all road safety and traffic laws, to ensure the safety of myself, my fellow riders and the general public. I have current and applicable vehicle liability insurance coverage from my own personal insurance provider. Under no circumstance will I operate a motor vehicle while under the influence of alcohol or any other illegal drug or controlled substance.
